#### Frame

The structures of our sofas are crafted using the materials best suited to preventing deformation due to wear. We ethically and carefully source our raw materials and work in Beech, Fir, and laminated timber for linear sections and MDF for rounded parts. Our spring system is made up of patented elastic belts that retain their characteristics over time.

#### Wadding

Three types of wadding are used in our products - polyurethane foam rubber, ducks' down, and staple fibre. Our foam rubber materials are harmless, environment friendly, non toxic, and can be recycled. Staple fibre, made up of thin strands of polyester, provides soft comfort to parts of couches like armrests, lower-back support, and backrests.

### Upholstery

Our couches can be covered in: Leather, Fabric, Micro-fibre.





Leather is a unique natural material which appreciates in value over time. STI leathers are carefully selected and treated in specialty leather works factories using advanced working and dyeing techniques. In an effort to retain the leathers natural qualities (wrinkles, scars, markings, shadings etc.) which are the defining qualities of any leather.

When we cover our products with leather it may require more stitching than the same product covered in a different material and once each hide has been processed, it maintains a unique qualities that cannot be imitated or replicated further increasing its value.








Micro Fibres are a type of synthetic fabric that are made up of very dense spinning processes particular compositions and qualities of the yarns used allow these fabrics to combine and produce new and desirable results, ranging from a pleasurable velvety feel to a durable tough but cushioned fabric.





- Do not use any sharp objects when opening the packaging as this could damage the product. • Do not pull on the product by gripping too tightly on delicate parts as this could also damage the product.
- Upholstered products may show creases or indentations due to transportation, but these disappear over time. We recommend shaping parts such as cushions using your hands to return them to their original shape.
- Over a couple of months sofa wadding softens as pressure exerted on it forces air out of the ٠ wadding decreases until it stabilizes.
- Try to use sofa seats evenly, in order to avoid uneven wear of the wadding.
- Leather has its own characteristic smell that reduces over time. Leather products may come with natural signs, that bear testimony to the value of the product. The appearance of wrinkles and folds over time is tantamount to the elasticity of natural hides.
- In order to keep sofa and armchair products intact and in perfect shape over time we recommended not sitting on backrest and armrests, as this tends to push their structural frames out of shape.
- We also recommend not using excessive force on your products.
- Our products should always be picked and moved from the base. We do not recommend pushing them around.
- To avoid losing the original colours of upholstered products, position the products away from heat sources and refrain from exposing them to direct sunlight.
- Finally if you buy the same upholstered product, there may be slight variations as the exact same tone and colour cannot be reproduced naturally.

- 2. Variety, type and specification. The type, variety and specification of the normal series sofa manufactured or distributed by our company are listed in Sheet 1. The special specification and size shall conform to the expressed contents of the contract.
